

# König Colour Touch-Up 240 000

## Uses

- To be used on wood, plastic and laminate surfaces.
- For a smooth, opaque touch-up by brush on plain colour surfaces.
- For re-dyeing and for achieving basic shades in the wood shade sector.
- To cover the substrate in case of veneer sand-throughs.
- To dye Rex-Lith Transparent, Wood and White 150-153.
- Recommended for both indoor and outdoor use.

## Characteristics

- Pigmented covering lacquer based on acrylic.
- Dries rapidly.
- High opacity.
- Can be varnished with all König touch-up and aerosol lacquers.
- Good adhesion to many lacquer, plastic and metal surfaces (not to Soft-PVC).
- Limited PVC-resistance (door and window gaskets).
- Good lightfastness and weather-resistance.
- Gloss sheen silk matt.
- Colours can be intermixed.

## Application

Shake up bottom sediments well before use. Mixing balls must be audible. Processed best at room temperature. Get your special colour by mixing different colour shades (mixing palette). More colour brilliance can be achieved by 'firing' either with Touch-Up Dye 220 or with Colour Concentrate 215.

## Specifications

**Processing recommended:** at 18-25°C and 55-65% RH  
**Dust-dry:** after approx. 1-2 minutes  
**Touch-dry:** after approx. 2-5 minutes (dependent on room temperature and coat thickness)  
**Lightfastness:** good  
**Weather resistance:** good  
**Shelf life:** at least 2 years (stored at room temperature, in original unopened container)

## Safety Precautions

- Highly flammable.
- Irritant.
- Keep away from sources of ignition. – No smoking.
- Do not breathe vapour.
- Use in well-ventilated areas, only.
- Keep out of reach of children.

## Disposal

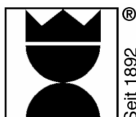
- Do not allow product to enter drains or watercourses.
