# **SECTION 4) FIRST-AID MEASURES**

#### Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by the POISON CENTER/doctor. Get Medical advice/attention if you feel unwell. ### **Eye Contact**

Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Remove contact lenses, if present and easy to do. ### **Specific Hazards in Case of Fire**

Fires involving this product may release oxides of carbon and nitrogen, reactive hydrocarbons, and irritating vapors. Fire will produce irritating and toxic gases. Most vapors are heavier than air. ### **Fire-fighting Procedures**

#### **Emergency Procedure**

# **SECTION 7) HANDLING AND STORAGE**

#### **General**

Wash hands after use. Do not breathe vapor or mist. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. All containers must be properly labelled. Do not get in eyes, on skin, or on clothing. Eyewash stations and showers should be available in areas where this material is used and stored ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area).

#### **Ventilation Requirements**

Use only with adequate ventilation to control air contaminants to their exposure limits. The use of local ventilation is recommended to control emissions near the source. Report ventilation failures immediately.

### **Storage Room Requirements**

Keep containers securely sealed when not in use. Containers that have been opened must be carefully resealed to prevent leakage. Indoor storage should meet OSHA standards and appropriate fire codes. Empty containers retain residue and may be dangerous. Store in cool, dry, well-ventilated areas away from heat, direct sunlight and strong oxidizers. Store in approved containers and protect against physical damage. Take precautionary measures against electrostatic discharge. To avoid fire or explosion, dissipate static electricity during transfer by ground and bonding containers and equipment before transferring material. Use non-sparking ventilation systems, approved explosion-proof equipment and intrinsically safe electrical systems in areas where this product is used and stored.

### 0013463-67-7 TITANIUM DIOXIDE

Is an IARC, NTP or OSHA carcinogen. In a lifetime inhalation test, lung cancers were found in some rats exposed to 250 mg/m3 respirable titanium dust. Analysis of the titanium dioxide concentrations in the rat's lungs showed that the lung clearance mechanism was overwhelmed and that the results at the massive 250 mg/m3 level are not relevant to the workplace. Results of a DuPont epidemiology study showed that employees who had been exposed to Titanium Dioxide were at no greater risk of developing lung cancer than were employees who had not been exposed to Titanium dioxide. No pulmonary fibrosis was found in any of the employees and no association was observed between Titanium dioxide exposure and chronic respiratory disease or x-ray abnormalities. Based on the results of this study DuPont concludes that titanium dioxide will not cause lung cancer or chronic respiratory disease in humans at concentrations experienced in the workplace.
